**State Income Tax Withholding Election Notice**  
 for Qualified Periodic and Non-Periodic Pension and Annuity Payments

Withholding of Oklahoma State income tax is required from the taxable portion of periodic and non-periodic pension and annuity payments made to residents of Oklahoma, unless you elect otherwise.

You may elect to have state income tax withheld even if no Federal income tax is being withheld. In addition, you may elect out of state withholding even if Federal income tax is being withheld. Please complete the form below and return it to the following address or fax it to (888) 499-4315.

**PERIODIC PAYMENTS:** Withholding must be calculated using the percentage of wages method if you have not elected out of Federal withholding. If you do not return this form, and you have not elected out of Federal withholding, Oklahoma state income tax will be withheld as if you claimed "married" with "three" exemptions.

**NON-PERIODIC PAYMENTS:** If you do not return this form, and you have not elected out of Federal withholding, 5% of the taxable payment will be withheld.

Your election will become effective with the payment that is due at least one month after our receipt of the election and will remain in effect until you change or revoke it. You may change or revoke your election by filing another election form with us. Copies can be obtained from the above address.

Please note that withholding is a method of paying taxes. It does not increase or decrease the total amount of taxes you must pay. Penalties may be incurred under the estimated tax payment rules if sufficient tax is not paid either through withholding, estimated taxes, or both.
